**POLICIES AND CONDITIONS:**1. Registration:

- Each student is considered enrolled when all forms are returned, and all fees paid.
- All accounts must be current before a family is accepted for re-registration including PIP hours.
- The re-registration fee reserves a place for each student and is non-refundable.

2. Tuition:

- All accounts must be current before a family is accepted for re-registration.
- Students will be allowed to begin a new year after all previous years' obligations are met.
- A student who is withdrawn, dismissed, or expelled must pay a prorated portion of tuition – based on current quarter and a \$100.00 withdrawal fee.

3. Parent Involvement Program (PIP):

- All families are required to contribute 20 hours at MVCA or MVCA-related events.
- Parents will endeavor to form a partnership with their children's teachers to strengthen the educational opportunity afforded to them.
- If parents have a concern or are dissatisfied, they will seek to resolve the issue with the person(s) directly. Parents agree to not gossip about teachers, staff, or other school families, but to follow the principle of Matthew 18:15-17.
